For-Hire Transportation Service License Renewal Reminder for 2019

To avoid the expiration of your current license and to provide continuous service, renewals for 2019 will need to be submitted to the Department no later than December 31, 2018. Please note that no operations can be conducted once your license has expired. If your license expires, you will be required to apply for a new license.

The Department will not be responsible for correspondences or permits returned to our office; due to invalid or out-of-date information **provided by the carrier**.
